Paul is a registered and Licensed Acupuncturist in the state of Colorado.

Paul's training includes therapies such as moxibustion, tui na, acupressure, cupping, auriculotherapy, and dietary and lifestyle recommendations. He continues to further his education in the fields of Advanced Chinese Medicine and Applied Nutrition. Paul is certified by the National Commission for the Certification of Acupuncture and is licensed with the Colorado Department of Regulatory Agencies and none of these licenses or certificates have been revoked or suspended.

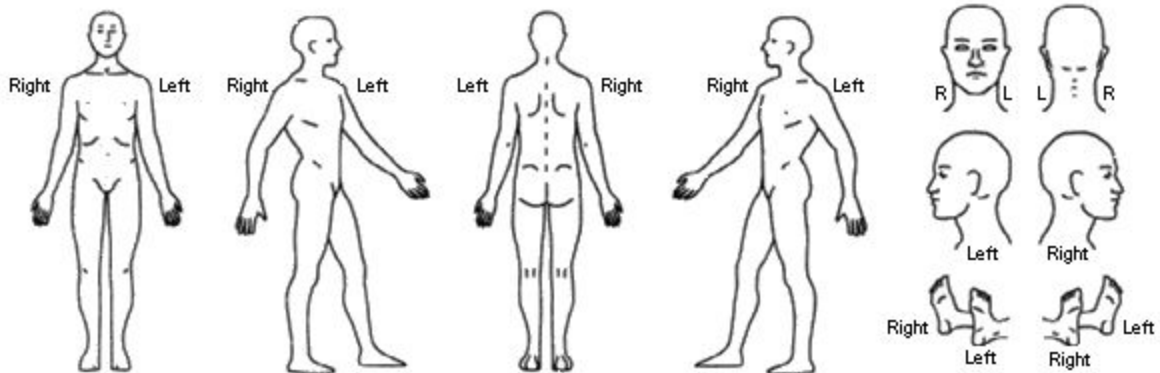
